Article 4: On Job Trainings

Hotel Bhawna Clarks Inn may, at its discretion, provide on job training sessions for students of the ITHM. The topics, duration, and other logistics will be mutually agreed upon in advance.

Article 5: Collaboration on Research and Development

The parties may explore opportunities for collaborative research projects, workshops, seminars, conferences and other initiatives aimed at fostering innovation and development in the relevant fields.

Article 6: Confidentiality

Both parties agree to maintain the confidentiality of any proprietary or confidential information disclosed during the collaboration.

Article 7: Duration

This MOU shall come into effect on the date of signing and remain in force for a period of five years. It may be renewed or amended by mutual consent in writing.
