Memorandum of Understanding

Dr. Bhimrao Ambedkar University, Agra, Uttar Pradesh

And

Maharaja Bir Bikram University, Agartala, Tripura

Dr. Bhimrao Ambedkar University, Agra, and Maharaja Bir Bikram University, Agartala have agreed to collaborate on academic and research related activities as follows:

1. Purpose:

Dr. Bhimrao Ambedkar University, Agra, the first party (henceforth called DBAUA) and Maharaja Bir Bikram University, Agartala, the second party (henceforth called MBBU) have many areas of common interest in various fields for their future growth. DBAUA and MBBU are entering into a Memorandum of Understanding (MoU) for mutual cooperation in the interest of both organizations. This MoU sets out the framework for the cooperative relationship between the parties to enhance quality of course and contribution towards the same by both the parties.



2. Scope:

The activities to be carried out under the range of this co-operation shall include-

- a) Exchange of faculties,
- b) Organize academic meetings, conferences, seminars, workshops, invited lectures, skill development programmes etc.
- c) Exchange of students,
- d) Interchange of teachers, researchers and students for the purpose of teaching, research and training to students,
- e) Exchange of academic documents as publications, scholarly materials etc. for both the Universities,
- f) Development of curriculum for both the Universities,
- g) Internship and training of students of DBAUA at MBBU and vis-à-vis,
- h) Training of employees of MBBU at labs of DBAUA,
- i) Proposal and execution of Joint Research Project by both the Universities,
- j) Corporate social responsibility activities of MBBU at DBAUA and vis-à-vis.

3. General Conditions:

- a) Both DBAUA and MBBU will endeavor to assist each other in the development of their educational services.
- b) It is aimed to outline an academic and management framework between the Universities they do not intend to be legally bound to each other and this MoU does not impose any legal obligation on either party.
- c) The undertaking of each activity to be carried out under the MoU will be subject to the availability of funds. Each University shall bear the expenses for its participation in the projects and activities to be carried out under this MoU.
- d) There will be Co-ordination Committee for effective execution of the activities to be carried out under this MoU and for reviewing their progress. The committee shall submit written report of the progress of the activities to be carried out under this MoU.
- e) Both DBAUA and MBBU will enjoy the benefit of Intellectual



Property Rights (IPR).

- f) This MoU outlines the framework of a working relationship between the parties. It is not intended to constitute a contract, but is built on goodwill and is binding in honor only. No partnership or joint venture is created by this MoU, and neither party can commit the other financially to third parties. There is no financial binding whenever necessary separate approvals will be obtained from relevant authority independent of this MoU.

4. Duration of MoU:

This MoU shall remain in force for a period of Five years from the date of signing. This MoU may be terminated or extended by mutual agreement of both DBAUA and MBBU in writing. The time of notice of any type from any party will be six months.
