Therefore, those present witnessed it, and it is hereby declared and agreed upon by and between the parties as follows:

- On behalf of Dr. Bhimrao Ambedkar University, Agra M/s Vishal Trading Company. Is it allowed to take out all e-waste from the premises of the university? Through his transportation system.
- 2. M/s Vishal Trading Company is also allowed to recycle the product from the E-waste at Dr. B.R.A. University, giving all permission to do the needful.
- 3. Dr. Bhimrao Ambedkar University, Agra, taking all the amounts inclusive of all taxes, M/s Vishal Trading Company will not be liable for any kind of tax. The rates for purchasing e-waste from Dr. Bhimrao Ambedkar University, Agra, shall be as per the annexure (A) forming part of this agreement.
- 4. After the purchase of e-waste, M/s Vishal Trading Company will be liable to pay the amount within 45 days.
- 5. Dr. Bhimrao Ambedkar University, Agra, is sailing all the e-waste in the form of scrap.
- 6. Dr. Bhimrao Ambedkar University, Agra, will provide all the documents related to e-waste, which is required for transportation, and related to taxes. According to the policies.
- 7. After purchasing the e-waste from Dr. Bhimrao Ambedkar University, Agra, M/s Vishal Trading Company can also re-sell the e-waste to general trading.
- 8. Cancellation of the agreement rights are reserved on the part of the university.
- 9. This agreement shall be valid for a period of five years from the date of this agreement.
- 10. The Dr. Bhimrao Ambedkar University, Agra, can cancel this agreement only if the payment terms mentioned are not fully fulfilled by M/s Vishal Trading Company. There is no other condition under which the university shall cancel this agreement during the period of five years starting from the date of this agreement.
