BACKGROUND:

Dr. Bhimrao Ambedkar University, Agra, and Native Concept, 73A Krishna Nagar, Agra Cantt Agra, recognize the importance of environmental sustainability and the utilization of natural resources. The University has an abundant presence of leaves on its campus premises, presenting an opportunity for sustainable waste management and resource utilization.

PURPOSE:

This Memorandum of Understanding (MoU) aims to establish a collaborative framework between Dr. BRA University and Native Concept for the conversion of leaves from the University campus into organic manure, contributing to environmental preservation and agricultural productivity.

TERMS AND CONDITIONS:

Collection of Leaves:

The First Party agrees to permit the Second Party to collect fallen leaves from designated areas within the University campus premises.

Transportation, Labour & Utility Requirements and Processing:

1. The First Party shall be responsible for the transportation, labour & utility requirements of collected leaves to its processing facility.
2. Native Concept shall undertake the necessary processing activities to convert the leaves into organic manure using eco-friendly methods.

Financial Assistance:

1. The First Party will be responsible for all the expenses during the followed process along with paying Rs1000 + GST per visit to the Second Party.
2. Also, the Second Party will be charging Rs1500 for training about the same to the First Party.

Quality Assurance:

The Second Party shall ensure that the organic manure produced meets the required quality standards and is free from any contaminants or harmful substances.

Utilization of Manure:

The First Party reserves the right to utilize the organic manure produced from the leaves within its agricultural and landscaping projects on the University campus.

This MoU shall come into effect upon signature by both parties and shall remain valid for a period of five years starting from 04/02/2023 to 05/02/2028.

Mutual Cooperation:

1. Both parties shall cooperate and coordinate effectively to ensure the successful implementation of the manure production project.
2. Any modifications or amendments to this MoU shall be made in writing and mutually agreed upon by both parties.
3. Both the parties agreed for conducting extension activities such as green initiative and environmental consciousness within the University Campuses and outside the campus within the city.

CONFIDENTIALITY:

Both parties agree to maintain confidentiality regarding any proprietary information or trade secrets disclosed during the course of this collaboration.

DISPUTE RESOLUTION:

In the event of any disputes or disagreements arising between the parties regarding the interpretation or implementation of this MoU, both parties shall endeavor to resolve them amicably through mutual discussions and negotiations.

REVISED ESTIMATE FOR LAYING OF SEWER LINE IN KHANDARI
EDUCATIONAL CAMPUS, AGRA UNIVERSITY, AGRA.

REPORT

The existing sewerage network in Khandari Educational Campus has been exhausted at present and sewage disposal from Khandari Educational Campus is not possible due to which a lot of inconvenience is caused to the habitats of Khandari Educational Campus as told by University Engineer. Logging of lot of wastewater is also occurring. This wastewater logging may also result in health hazard. In reference to the Letter No 171/NaNi/November-2017 of Hon'ble chairman of SC-ST Commission, Municipal Commissioner, Agra vide his office letter no 400/D/NA/17 dated 06/11/2017 ordered for laying of sewer line and connect the same to the existing main sewer line so as to dispose the wastewater from Khandari Educational Campus.

Previously an estimate costing Rs. 89.33 Lakhs was presented to the university but as informed by University Engineer that some more components like branch sewer line, house connecting chamber, sewer house connections of all campus buildings, etc. are also to be considered. The proposed areas were inspected and proposed sewer network was marked by Er. Hari Mohan Sharma, University Engineer, Agra University, Agra in the joint visit of Khandari Campus and drawing was approved by the university received vide Letter No. Prasha/ 1080 dated 15.11.2019. So, a revised estimate is prepared incorporating the demand.
