One-Day Workshop on Patent Filing Organized by IPR Cell, Dr. Bhimrao Ambedkar University, Agra

On the occasion of World Intellectual Property (IP) Day, a one-day workshop on Patent Filing and Intellectual Property Rights was organized by the IPR Cell of Dr. Bhimrao Ambedkar University, Agra.

The workshop began with a welcome address by Dr. Kriti Sharma, followed by an introductory note by Prof. Gautam Jaiswar, Convener of the IPR Cell. He introduced the theme of World IP Day 2025 and highlighted the crucial role of Intellectual Property Rights in driving innovation, creativity, and societal progress.

An interactive session was also held with the Hon'ble Vice Chancellor, where she stressed the importance of entrepreneurship and innovation among students. She encouraged copyright filing, particularly in the Department of Fine Arts, and advocated for strengthening the university's incubation system by leveraging MSME funding schemes. She noted that nurturing innovative ideas can create a significant positive impact on society. She further recommended conducting more sessions focused on copyrights and patent case studies.

The session concluded with the announcement of an Essay Writing Competition, and the "Most Innovative Idea" award was presented by the Hon'ble Vice Chancellor to Alpana Maurya, Aditya Kashyap, Arpit Kashyap, Tapas Kushwaha, and Prachi Bhadoria. She congratulated all the winners for their outstanding contributions.

Prof. Devendra Kumar, Head of the Department of Chemistry, delivered the vote of thanks. He expressed his gratitude to the Hon'ble Vice Chancellor, all the esteemed speakers, IPR Cell members, faculty, and students for their enthusiastic participation and support in making the workshop a success.


