Dr Bhimrao Ambedkar University (NAAC A⁺) was laid on the 1st of July 1927, is a state University, established by Government of UP vide University act 1973.

At present University has 600+ affiliation spread over four districts and forty five residential departments/institutes in its four campuses. University has 178 programmes in 16 faculties and integrated Information and Communication Technology (ICT) tools. Many of the great leaders of India was alumni of the university viz. Pt. Deen Dayal Upadhyay, Sri. Atal Bihari Bajpayee, Sri. Moti Lal Nehru, Sri. Ajeet Doval, Ch. Charn Singh, Sri. Bhagwan Singh.

Dr. Rammanohar Lohia Avadh University, Ayodhya, was established in 1975 as an affiliating university, with Prof. (Dr.) Surendra Singh as its first Vice-Chancellor. Renamed in 1993-94 to honor freedom fighter Dr. Rammanohar Lohia, it began in a rented building and expanded to its current campus in 1978. Transitioning to an affiliating-cum-residential university in 1984, it launched several PG departments. Over time, programs in engineering, technology, and various other disciplines were added, with the Institute of Engineering & Technology established in 2000-01. Today, it educates around 5 lakh students through nine PG departments, an engineering institute, and 700+ affiliated colleges across seven districts. Purpose of MOU

The purpose of this MoU is to establish a framework for collaboration and cooperation between Dr. Bhimrao Ambedkar University, Agra and Dr. Rammanohar Lohia Avadh University, Ayodhya in areas of mutual interest, including but not limited to academic exchange, research activities, entrepreneurship development and faculty development.

Key Areas of Cooperation:

1. Joint Skill Developments

Both the universities shall work jointly to explore opportunities for developing programmes and skill development initiatives in multiple areas.

2. Entrepreneurship Development.

Joint organization of conference / workshop / seminar / symposia/summer school / training / faculty development programme /lectures etc. to improve the exchange of knowledge and experience.

3. Industry Exchange Programme

Both the universities shall work jointly for the exchange of faculties / Experts depending on the requirement and experience for the benefit of the students and the research scholars.

4. Exchange of Knowledge Resource

Sharing of books, journals and teaching materials including textbooks, audio-videos, publications, reports and other teaching aids through their respected libraries.

5. Joint Research Programs and Projects

Recognizing the mutual desire to strengthen academic and research cooperation, both universities collaborate on a joint research program to promote academic excellence, innovation, and shared expertise.

6. Cultural Exchange Program

To promote cultural awareness, diversity, and collaboration among students and faculty from both universities and provide opportunities for students and faculty to experience and learn about each other's cultures, traditions, and values.


